We are looking for a candidate with experience in theoretical/mathematical physics. The tasks of the scholarships' holders will be to write a doctoral thesis based on research on shallow quantum circuits.

The application must include:

- 1. The scientific CV, including the progress in the university studies, scientific achievements (publications, participation in research projects and conferences).
- 2. Motivation letter.
- 3. A copy of the master's degree diploma
- 4. Copies of documents confirming scientific or professional achievements.
- 5. Optionally, a letter of recommendation from a researcher with at least a PhD degree, concerning the candidate and his/her current scientific activity.
