

Competition for the position of Professor/Assistant Professor at the Center for Theoretical Physics PAS

The Director of the Center for Theoretical Physics PAS (CTP PAS) announces a competition for the researcher position at CTP PAS. The competition is open to candidates who, at the date of the announcement, hold at least a PhD degree and have a substantial scientific record which meets the requirements for candidates applying for a habilitation degree in Poland.

Candidates are expected to have significant scientific achievements in the field of theoretical physics, a proven record of obtaining research grants, supervision of BSc, MSc and/or PhD students. A successful candidate is supposed to establish their own research group at CTP PAS. A track record of research at the boundaries of physics and mathematics will be an additional asset.

Interested candidates should provide the following documents in pdf:

- a motivation letter stating the proposed date of employment at CTP PAS,
- short description of their past and planned research, including justification (max. 4 pages),
- scientific CV,
- list of their publications,
- list of the research projects he/she has managed and functions related to research administration,
- a statement confirming that CTP PAS will be your primary place of work if you win the competition,
- documents confirming the scientific degree,
- other documents that may significantly influence the assessment of the candidates,
- consent to the processing of personal data (form in the attachment)

Documents should be sent to rekrutacja@cft.edu.pl. Candidates should also obtain at least two recommendation letters sent independently to the same e-mail address. Please write reference number **CFT/17/2022** in the subject line of the e-mail.

The candidate may be asked to publicly present her/his scientific work in the form of a talk at the CTP PAS.

The deadline for submission of documents is **31 March 2023**.

The competition will be settled by **15 April 2023**. The Faculty members will decide the competition, assessing scientific achievements, experience in conducting research projects and scientific potential. The competition may not be decided if there are no sufficiently strong candidates.

Planned remuneration in the range of PLN 8,000 to 10,000 gross per month. Candidates will be notified in writing of the results of the competition.

The competition winner with a degree "Doktor Habilitowany" will be offered employment at CTP PAS as a professor. After one year of work and a positive opinion of the Scientific Council, the winner will be offered a permanent position.

If the winner is before habilitation, he/she will be offered an assistant professor position. In this case, the winner must apply for a habilitation within 12 months of starting the employment. Once the habilitation is awarded and the Scientific Council has given a positive opinion, the winner will be offered a permanent position.

Information Clause – Job Recruitment

Information Obligation under the Article 13 of the RODO *:

1. Data Administrator

3. The Purposes of Processing and the Legal Basis for Processing

Your personal data will be processed for the purpose of running the current recruitment. The basis for the processing of personal data are the provisions of the Labor Code Act of June 26, 1974 (uniform text: Dz. U. of 2018, item 917) and based on your consent for data processing.

4. The Period of Storage of Personal Data

Your personal data will be kept for the duration of the present recruitment.

5. Data Recipients**

The recipients of your personal data will be only entities authorized to obtain personal data on the basis of the law. Access to your data is provided only to employees authorized by the administrator and associates who must have access to the data to perform their duties.

6. Your Processing Rights

You have the right to access your data and the right to correct it or limit processing, as well as the right to appeal against the processing.

7. The Obligation to Provide Data and the Consequences of not Providing Data

Providing your personal data specified in the Labor Code is obligatory, and for the remaining extent voluntary.

8. The right to make a complaint to the President of the Office for the Protection of Personal Data

When you feel that the processing of personal data violates the provisions of the general regulation on the protection of personal data, you have the right to make a complaint to the President of the Office for the Protection of Personal Data.
